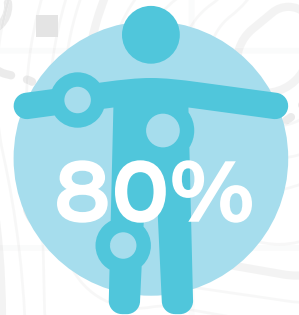

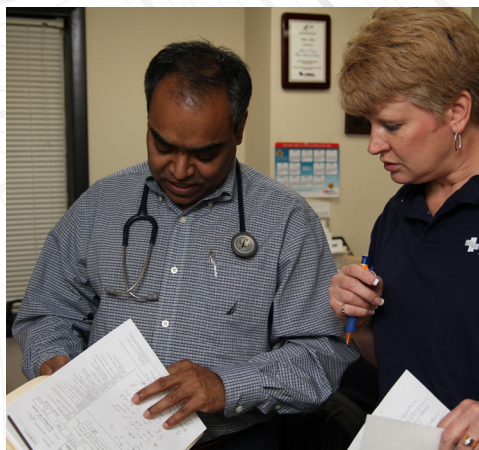
The State of Iowa invested \$334,870 in its free clinics – the Return on Investment yielded **\$5 for every \$1** invested.¹
